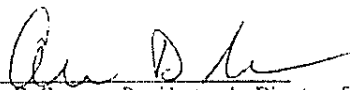

These Articles of Conversion and attached Articles of Organization are submitted to convert the following Florida corporation into a Florida limited liability company in accordance with Section 605.1045, Florida Statutes.

1. Name of Converting Entity. The name of the corporation immediately prior to the filing of the Articles of Conversion which is converting into the Florida limited liability company is: Green Construction Services, Inc. (the "Converting Entity").
2. Jurisdiction of Formation and Type of Converting Entity. The Converting Entity is a corporation incorporated under the laws of the State of Florida having a document number of J82952, organized on July 16, 1987.
3. Name of Converted Entity. The name of the Florida Limited Liability Company that is the converted entity is: Green Construction Services, LLC (the "Converted Entity").
4. Jurisdiction of Formation and Type of Converted Entity. The Converted Entity is a limited liability company organized under the laws of the State of Florida first organized on December 21, 2016.
5. Articles of Organization of the Converted Entity. A copy of the Articles of Organization for the Converted Entity are attached as Exhibit A.
6. Approval of Plan of Conversion. The Plan of Conversion was approved by all of the shareholders and directors of the Converting Corporation all in accordance with applicable Florida Statutes.
7. Appraisal Rights. The Converted Entity has agreed to pay any shareholders of the Converting Entity having appraisal rights the amount to which they are entitled under Sections 607.1301 - 607.1333, Florida Statutes.
8. Effective Date of Conversion. This conversion shall be effective in Florida on January 1, 2017.

ARTICLES OF ORGANIZATION
OF
GREEN CONSTRUCTION SERVICES, LLC
