
To Whom It May Concern:

I, Christian Cope, am the managing member of 30A Enterprises LLC. This entity was originally formed on January 15, 2014 with Document Number L14000009141. I voluntarily dissolved this entity online on December 14, 2016 to be effective as of December 31, 2016. At the same time, I registered a new LLC online under the same name of 30A Enterprises LLC to be effective as of January 1, 2017. This was done in order to clear up some confusion with the IRS and the State of Florida regarding sales tax returns, EIN matching, and entity type changes.

I received a notice of rejection for this newly created entity on December 15, 2016 stating that it could not be established since the 30A Enterprises LLC name is held for 120 days by the State of Florida. I have been instructed to send this signed statement declaring that I release the name to be used again for my new entity and that I have no intentions of ever reinstating the old entity under Document Number L14000009141.
