**ARTICLES OF ORGANIZATION
FOR

The undersigned, acting as the organizer of KRIR HOLDING COMPANY, LLC under the Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:
