ARTICLES OF ORGANIZATION


ARTICLE VI. MANAGEMENT OF COMPANY



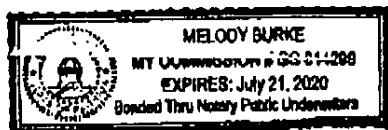
