**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **TARPON BAY IV, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of January 1, 2017, and shall thereafter be perpetual.
