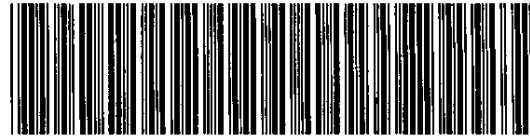

The undersigned, pursuant to the provisions of Chapter 605, Florida Statutes (the Florida Revised Limited Liability Company Act"), for the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

**ARTICLE I
NAME**

The name of the limited liability company is John A. Owenby, LLC. (hereinafter referred to as the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall have perpetual existence unless earlier dissolved as provided in the Florida Revised Limited Liability Act or the Operating Agreement to be executed by all of the Members of the Company.

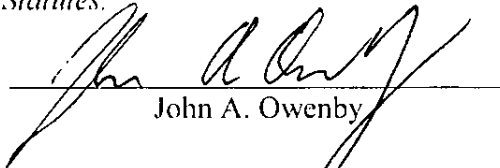

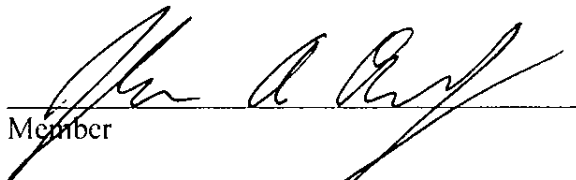

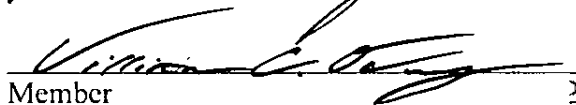
