
ARTICLE VI. MANAGEMENT OF COMPANY





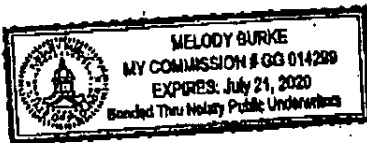
