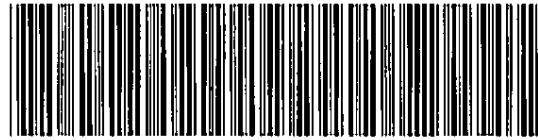


1. The name of the limited liability company is TB HOMES LAND XXVIII, LLC.
