

## AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR ONYX WOLFCHASE HOTEL, LLC

The undersigned, being desirous of forming a limited liability company pursuant to Chapter 605, Florida Statutes, hereby certifies as follows:

- 1. Name and Purpose. The name of the limited liability company is ONYX WOLFCHASE HOTEL, LLC a Florida limited liability company (the "Company"). The purpose of the limited liability company shall be solely to acquire, own and hold the real property commonly known as 2785 New Brunswick Road, Memphis, TN 38133 (the "Property") and to operate a hotel on the Property, together with such other activities may be necessary or incidental in connection with such purposes, and for no other purpose.
