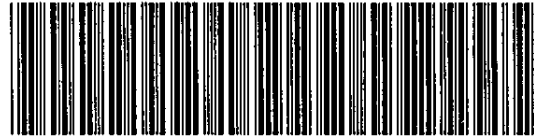

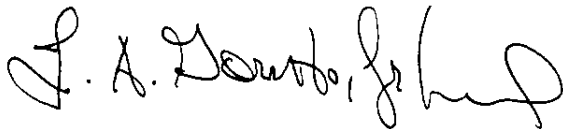

NAME

The name of this limited liability company is Radiology Data and Research.com, LLC.

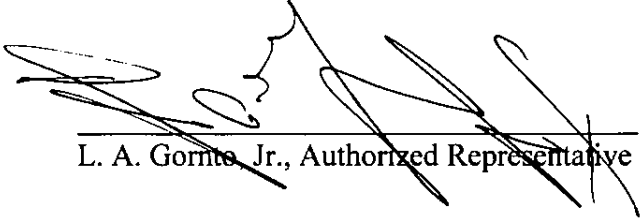

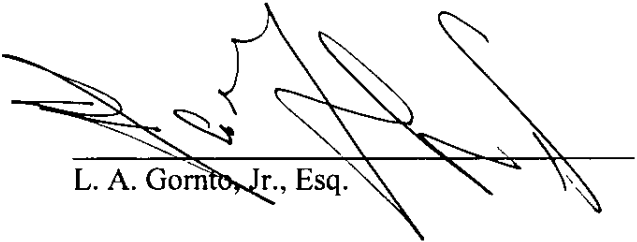
