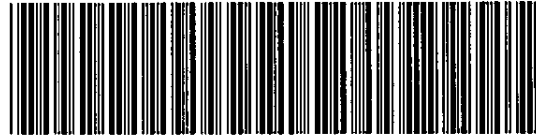

ADDRESS**

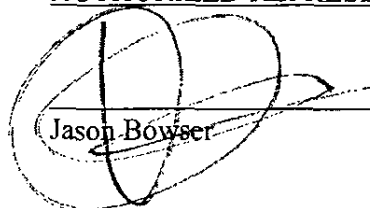

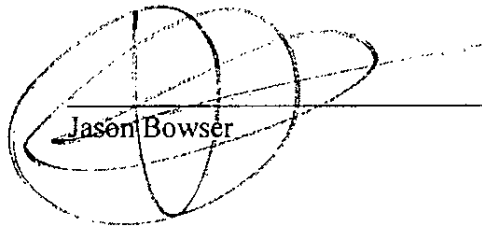
