These Articles of Merger are submitted in accordance with Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), with respect to the merger of Anesthesia Associates of Osceola, LLC, a Florida limited liability company ("AAO"), with and into Osceola Gastroenterology Anesthesia Associates, LLC, a Florida limited liability company ("Osceola Gastroenterology"). Osceola Gastroenterology is hereinafter sometimes referred to as the "Surviving Entity", and the merger that is the subject of these Articles of Merger are hereinafter referred to as the "Merger".

- The Surviving Entity agrees to pay any members with appraisal rights the amount, to which members are entitled under Sections 605.1006 and 605.1061-605.1072, Florida Statutes.
 - 7. The effective date of the Merger is upon the filing of these Articles of Merger.
- These Articles of Merger may be signed in multiple counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument
