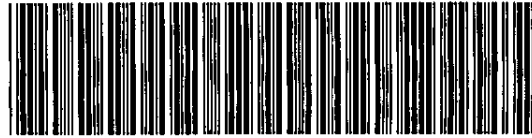



**ARTICLES OF ORGANIZATION
FOR

ARTICLE I: NAME OF COMPANY

The company is to be managed by one or more of its members and is therefore a member-managed company. The initial managing member is SARAH L. MARKOFSKI, at the principal office stated above.


ARTICLE VI: REGISTERED AGENT
