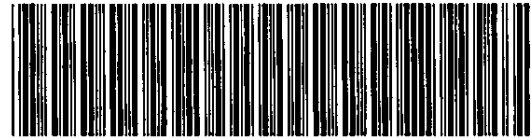

ARTICLES OF ORGANIZATION

CLAYTON LAW, PLLC

The undersigned, being a member or duly authorized representative of a member, desiring to form a professional limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I — NAME:


