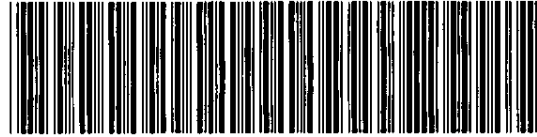

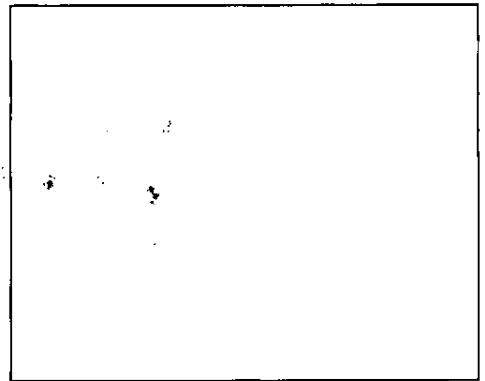

**NAME**
