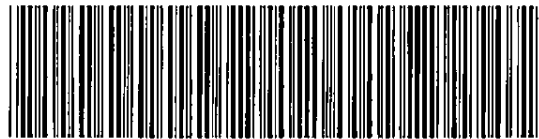

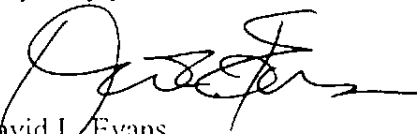

Pursuant to Florida Statutes Section 605.0707, Atlantic Coast Holdings, Inc., as sole Member of HOSC GP, LLC, a Florida limited liability company (the "Company"), has adopted the following articles of dissolution:
