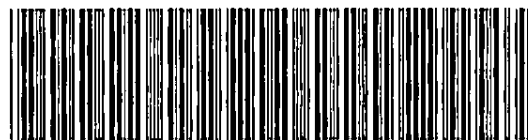



CERTIFICATE OF TRUST
THE WILMOTH O. EDWARDS, SR. AND HAZEL EDWARDS
JOINT REVOCABLE TRUST
DATED JUNE 3, 2020

We, WILMOTH O. EDWARDS, SR. and HAZEL EDWARDS, of Flagler County, Florida, make this Certificate of Trust as a summary of certain provisions contained in that certain Trust Agreement known as the "WILMOTH O. EDWARDS, SR. AND HAZEL EDWARDS JOINT REVOCABLE TRUST dated June 3, 2020." The effective date of the Trust is June 3, 2020. The initial Trustees are WILMOTH O. EDWARDS, SR. and HAZEL EDWARDS. In the event of the resignation, incapacity, or death of both initial Trustees, then DELANO RANDOLPH (Baldwin, New York) shall serve and has been designated as Successor Trustee. In the event of the resignation, incapacity, or death of DELANO RANDOLPH, then WILMOTH O. EDWARDS, II (Portland, Oregon), shall serve and has been designated as Successor Trustee.


Said Trust provides that the Trustee and any Successor Trustee shall have all of the powers and protection granted to them by statute at the time of serving hereunder including, but not limited to, the prudent investor rule, Revised Florida Principal and Income Law, Florida Trust Administration Act, and the Florida Probate Code (all as may be amended from time to time). The powers herein granted to the trustee shall include the full power of sale, elections as to tax matters, loans, leases, and investments, and to alter investments and execute releases, and to make divisions of the assets of the Estate in cash or in kind. All such powers and discretions herein given to the Trustee may be exercised without application to any Court or any Court order.


The "WILMOTH O. EDWARDS, SR. AND HAZEL EDWARDS JOINT REVOCABLE TRUST dated June 3, 2020" is a revocable living trust with the Grantor reserving the right to revoke, alter, or amend the Trust at any time. The Grantor retains the requisite beneficial interest and possessory rights in and to their homestead real property to comply with Section 196.041 Florida Statutes, or any successor statute, so that such requisite beneficial interest and possessory rights constitute in all respects "equitable title to real estate" as that term is used in Section 6, Article VII of the Constitution of the State of Florida.




expected to inquire further as to the application or distribution of the assets and funds contained in said Trust.


