**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF  
DDER DEVELOPMENT, LLC.**

The undersigned, as a manager of DDER DEVELOPMENT, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is DDER DEVELOPMENT, LLC.
2. The date of the filing of the original Articles of Organization of the Company was January 26, 2017.
3. The Articles of Organization of the Company are hereby amended by deleting Article IV entitled "Management" in its entirety and inserting the following section in its place and stead:

**ARTICLE IV - Management:**
