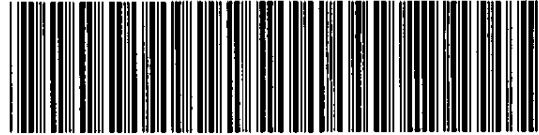

The name of the Company shall be Trevor Milam Maintenance, LLC.


ARTICLE II.
