## ARTICLES OF DISSOLUTION OF EMERALD ISLAND PARK, LLC

EMERALD ISLAND PARK, LLC, a Florida limited liability company, pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), by its Members, hereby sets forth its Articles of Dissolution.

## ARTICLE I.

The name of the limited liability company is EMERALD ISLAND PARK, LLC.

#### ARTICLE II.

The Articles of Organization were filed on January 27, 2017 and assigned document number of the company is L17000022505.

# ARTICLE III.

The dissolution was authorized by the consent of all of the company's Members on November 28, 2022 and by Final Judgment decreeing dissolution entered on November 30, 2022 in the Walton County Circuit Court of the First Judicial Circuit of the State of Florida, in the following cases Case No. 2018 CA 352; Case No. 2019 CA 344; and 2019 CA 530 to which Emerald Island Park, LLC and all of the interested parties and members were joined. Said Final Judgment authorized Theresa Odom to dissolve Emerald Island Park, LLC. The effective date of the dissolution shall be the date of filing.

#### ARTICLE IV.

In accordance with Section 605.0701(2) of the Act, dissolution was directed and approved by all of the Members and interested parties entitled to vote on the matter and the Judgment of the Walton County Circuit Court decreeing dissolution. The number of votes cast for dissolution was sufficient for approval.
