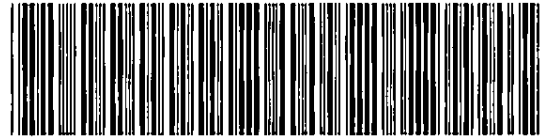

FIRST: The name of the Limited Liability Company is **54 GREENE, LLC**.


SECOND: The Articles of Organization were filed on January 30, 2017, and assigned document number L17000022850.


