ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Floride Limited Liability Company Act, Florida Statutes Chapter 605, Rereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be CUSTOM EMBROIDERY CREATIONS LLC ("Company").
