The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be GADUC LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 99 Shore Drive West, Miami, Florida 33133 and the mailing address, shall be the same.

ARTICLE 3 - EFFECTIVE DATE
