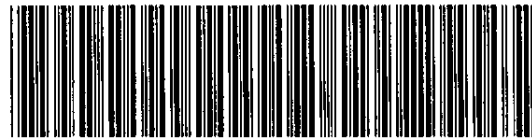

**ARTICLES OF ORGANIZATION
FOR
CB ROOTS, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned desiring to form a Limited Liability Company pursuant to Chapter 605 of the Florida Statutes, does hereby certify:

**ARTICLE I
NAME**

The name of the Company shall be CB Roots, LLC, hereinafter referred to as "the Company."

**ARTICLE II
LOCATION**

The principle place of business and mailing address of the Company shall be 918 9th Court, Palm Beach Gardens, Florida 33418, in the county of Palm Beach, or at such other location within the State of Florida as may be hereafter established by the Members or Managers.

**ARTICLE III
PURPOSE**

The Company is organized to offer unprocessed, freshly prepared, ready to eat meals utilizing locally sourced ingredients, at affordable prices, and for health-minded, convenience seeking clients. The Company is authorized to transact any and all lawful business for which a limited liability company may be organized under Florida law that is incident, necessary and appropriate to accomplish the foregoing.

**ARTICLE IV
DURATION**

The Company shall have perpetual existence, unless sooner dissolved in accordance with Florida law.

**ARTICLE V
MANAGERS**

The Company shall be managed managers as authorized in this Article. The persons so authorized shall serve as the initial Managers of the Company. Each Manager, whether acting alone or with other authorized Manager[s], shall have authority to act for or to bind the Company.

Florida Statutes, known as the Florida Revised Limited Liability Company Act, as amended or revised from time to time and these Articles of Organization as amended or revised from time to time. Amendments to the Articles of Organization of the Company will be adopted with the unanimous written consent of the members.

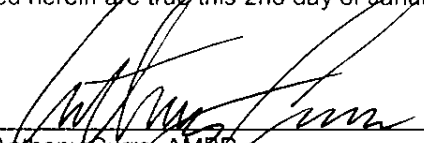
**ARTICLE VI

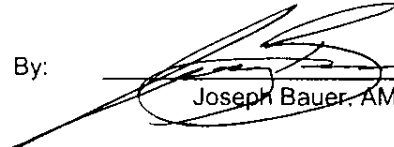
