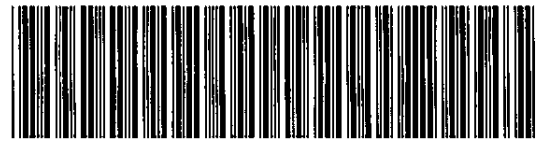

The undersigned authorized representative does hereby certify that a limited liability company ("Company") is hereby formed under the laws of the State of Florida (including the Florida Limited Liability Company Act) as follows:

**ARTICLE I**  
**NAME**

The name of the Company shall be:

RRR2, LLC

**ARTICLE II**  
**PURPOSES**

The Company may engage in the transaction of any or all lawful business for which limited liability companies may be formed under the laws of the State of Florida.

**ARTICLE III**  
**GENERAL POWERS**

The Company shall have the power to undertake any and all activities and actions authorized under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE IV**  
**ADDRESS AND PLACE OF BUSINESS**

The mailing and street address for the Company is 2165 Louisa Drive, Belleair Beach, Florida 33786.

## **ARTICLE V OPERATING AGREEMENT**

The members of the Company shall adopt an Operating Agreement of the Company pertaining to the regulation, management and affairs of the limited liability company, provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be modified in the manner set forth in the Operating Agreement consistent with the laws of the State of Florida.

## **ARTICLE VI MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of one or more managers. The managers shall have all powers set forth in the Operating Agreement. The name and current address of the initial manager is Owen Ewing, 2165 Louisa Drive, Belleair Beach, Florida 33786.

## **ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS**

No new members shall be admitted to the Company except as provided in the Operating Agreement. Restrictions and conditions on membership may be set forth in the Operating Agreement.

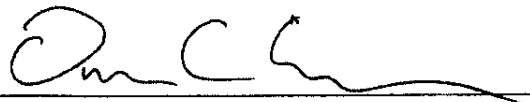
## **ARTICLE VIII REGISTERED OFFICE AND REGISTERED AGENT**
