ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name of Limited Liability Company

The name of this limited liability company is TDO VENTURE, LLC (the "Company"), with its principal place of business being located at 9881 North Belfort Circle, Tamarac, Florida 33321 and the mailing address is the same.

ARTICLE II

Duration

The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Chapter 605, Florida Statutes unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Purpose

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE X
Certificated Interests

The members' interests in the Company shall be evidenced by certificates.

ARTICLE XI
Contracting Debts

All contracting debts of the limited liability company require the approval of one of the managers.


