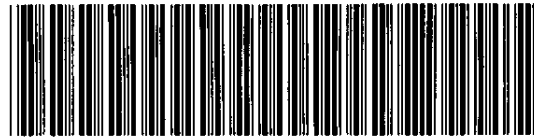

The member(s) shall have the right to admit additional members only upon the unanimous consent of all members.


#### ARTICLE VI Members – Rights to Continue Business
