**ARTICLES OF ORGANIZATION  
OF  
FLORA-BAMA HOLDINGS, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Flora-Bama Holdings, LLC (the "Company"). The Company's principal address and mailing address is 12345-D 62<sup>nd</sup> Street North, Largo, Florida 33773. The Company's initial registered agent is David M. 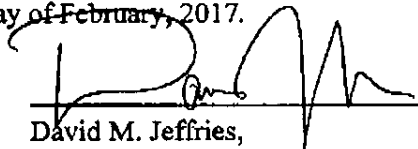

**Indemnification**

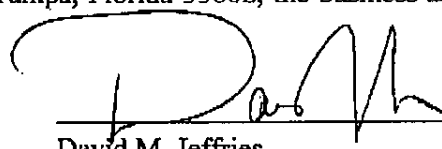

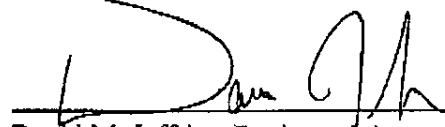
**CERTIFICATE DESIGNATING**
