The undersigned hereby submits these Amended and Restated Articles of Organization (these "Articles of Organization") for MSGOLD HOLDINGS ORLANDO LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat.

These Articles of Organization amend and restate in the entirety any prior articles of organization previously filed on behalf of MSGOLD HOLDINGS ORLANDO LLC organized with the Florida Secretary of State on February 13, 2017.

ARTICLE I - Name:

The name of the limited liability company is MSGOLD HOLDINGS ORLANDO LLC, a Florida limited liability company (the "Company").

ARTICLE II - Address:
