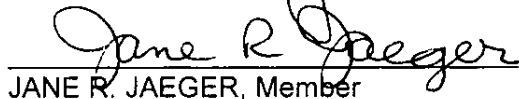
Article VI

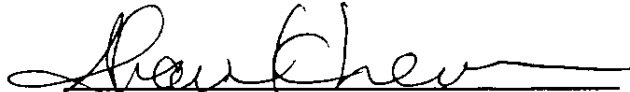
