SMASH MOUTH (PA), LLC, a Florida limited liability company (the “Company”), pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the “Act”), hereby adopts the following Articles of Dissolution:

ARTICLE I
NAME

The name of the Company is SMASH MOUTH (PA), LLC. The Articles of Organization were filed on February 10, 2017 and assigned document number L17000033305. The Articles were subsequently amended by those certain Articles of Amendment to Articles of Organization on August 29, 2019.

ARTICLE II
EFFECTIVE DATE

The effective date of these Articles of Dissolution shall be the date of filing of the Articles with the Department of State.

ARTICLE III
ELECTION TO DISSOLVE

Pursuant to the Operating Agreement of the Company, dated as of February 10, 2017, the Member of the Company (as required by and defined in the Operating Agreement) elected to dissolve the Company by written consent dated effective as of March 22, 2021.

ARTICLE IV
NO OBLIGATIONS

All debts, obligations, and liabilities of the Company have been paid or discharged.

ARTICLE V
DISTRIBUTION OF PROPERTY

All of the remaining property and assets of the Company shall be distributed to the Member of the Company in accordance with its respective rights and interests as reflected in the Operating Agreement of the Company.

ARTICLE VI
NO SUITS
