The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida hereby sets forth the following:


1. NAME. The name of the Limited Liability Company is: **COLLEGIUM FL, LLC** (the "Company").


