**ARTICLE I**

(Name and Principal Place of Business; E-mail address)

(Duration and Purpose)

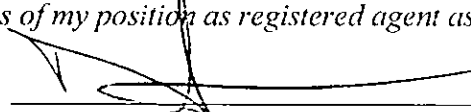

(Management)

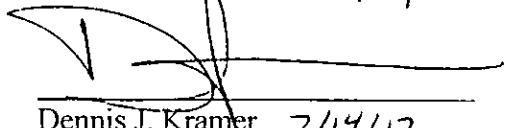
