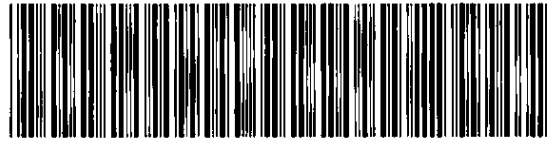


Article 5. - Management


