The Company shall be managed by one or more managers as provided in the Company's Operating Agreement. The initial managers and their addresses are:

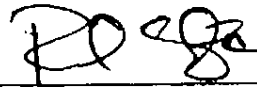

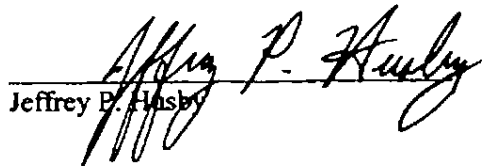
