3. Amendment. The Articles of Organization of the Company are hereby amended as follows:

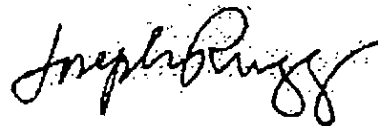
Article I is deleted and a new Article I is inserted in lieu thereof, to read as follows:
