**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I  
NAME**

The name of this limited liability company is Barefoot Maintenance Specialists, LLC, a Florida limited liability company (the "Company").

**ARTICLE II  
DURATION**

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

TERMINATION OF MEMBERSHIP**

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership

of a member in the Company, the Company shall be dissolved unless the remaining members, if any, by unanimous written agreement, consent to continue the business of the Company.

**ARTICLE VII**  
**MANAGEMENT OF THE COMPANY**


**ARTICLE VIII**
