

ARTICLES OF ORGANIZATION

OF

Mowery Enterprises, LLC



The undersigned person, acting hereby as Organizer for the purpose of forming in the liability company under the Florida Statutes, Chapter 605, hereby executes the following Articles of Organization:

- I NAME. The name of the limited liability company shall be: Mowery Enterprises, LLC ("Company").
