The undersigned hereby gives notice of and certifies, under penalties of perjury, the following facts with respect to Simoes Davila, PLLC (the "Company"):

- 1. Effective December 16, 2019, the Company, its member/manager The Simoes Law Group, P.A. ("SLG"), and its member Julio D Davila Law Group, P.A. ("JDDLG") entered into the Amended Operating Agreement of Simoes Davila, PLLC (the "Operating Agreement").
- 2. In early 2021, JDDLG ceased to be a member pursuant to the terms of the Operating Agreement, leaving SLG as the only member of the Company.
- 3. As the Company's sole member and pursuant to Section 13.1(a) of the Operating Agreement, SLG filed Articles of Dissolution with the Department on November 24, 2021.
- 4. On January 3, 2022, JDDLG caused to be unilaterally filed a "Statement of Revocation of Dissolution," without the knowledge or consent of the undersigned or SLG. The filing was unauthorized by SLG and therefore does not represent the position of the Company.
- 5. On January 10, 2022, JDDLG caused to be unilaterally filed a 2022 annual report for the Company, without the knowledge or consent of the undersigned or SLG. The filing was unauthorized by SLG and therefore does not represent the position of the Company.
- 6. The parties are currently engaged in litigation over the Company pending in the Eighteenth Judicial Circuit in Seminole County Florida, *Davila v. Simoes*, Case No. 2021-CA-002895.

7. The Department and all persons transacting with JDDLG or the Company are hereby notified that (1) JDDLG and his principal, Julio D. Davila, do not have authority to file documents with the Department or to otherwise act on behalf of the Company, and (2) the Company has been dissolved by SLG as the managing member and is in the process of winding up its activities pursuant to the Operating Agreement.
