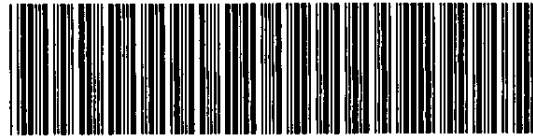

The name of the Limited Liability Company is BACCHUS FM MANAGEMENT LLC


