Having previously formed and created a limited liability company pursuant to Chapter 605 and <u>Fla. Statutes</u> \$605.0201 of the laws of the State of Florida, I do hereby execute and adopt these Amended and Restated Articles of Organization to be filed with the Florida Department of State and do hereby state and certify the following, pursuant to \$605.0202, <u>Florida Statutes</u>:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

In accordance with Fla. Stat. \$605.0112 and \$605.0201(2)(a), the limited liability company's name shall be

ARTICLE II - PERIOD OF DURATION OF LIMITED LIABILITY COMPANY
