**ARTICLES OF ORGANIZATION
OF
ALIANNA ENTERPRISES, LLC**

The undersigned, Anna Debecki, a natural person competent to contract and an authorized representative of ALIANNA ENTERPRISES, LLC, files these Articles of Organization of ALIANNA ENTERPRISES, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ALIANNA ENTERPRISES, LLC, which is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS

ARTICLE VI - MANAGEMENT

The Company shall be managed by a manager or managers in accordance with the terms of the Operating Agreement of the Company.

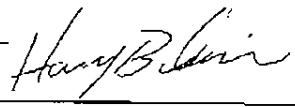
