The name of the limited liability company is Swan Street Capital LLC.

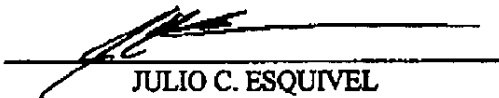
**ARTICLE II. ADDRESS**
