**ARTICLES OF ORGANIZATION
OF

The undersigned, Adelene Lovelace, a natural person competent to contract and an authorized representative of GARDEN STREET HOLDINGS, LLC, hereby presents these Articles of Organization as the Articles of Organization of GARDEN STREET HOLDINGS, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is GARDEN STREET HOLDINGS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
