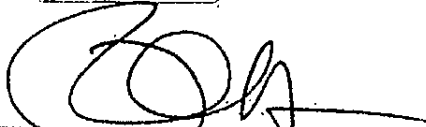
ARTICLE IV

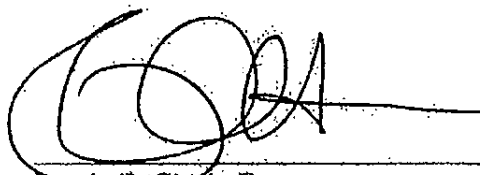
