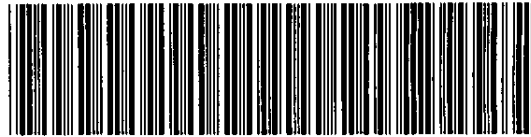

PURPOSE AND POWERS**




