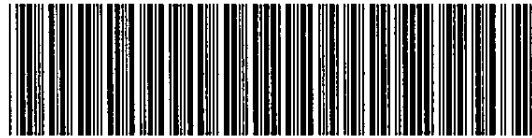

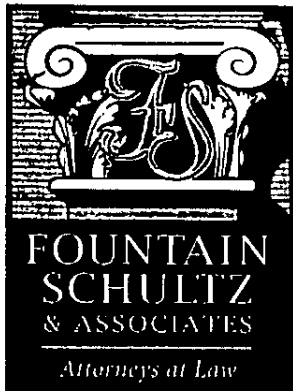



ARTICLE X - AMENDMENT

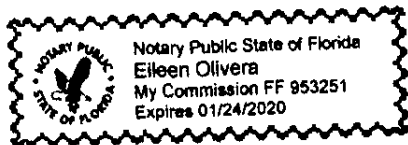

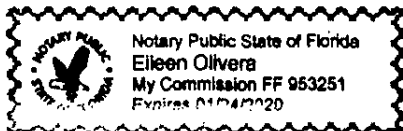

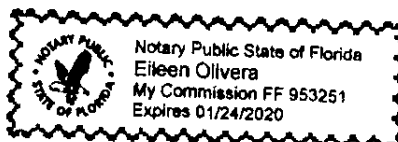
