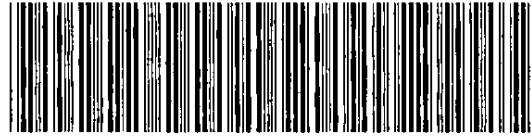

The Original Articles of Organization for this Limited Liability Company (the "Company") were filed on February 24, 2017, and assigned Florida document number L17000044801.

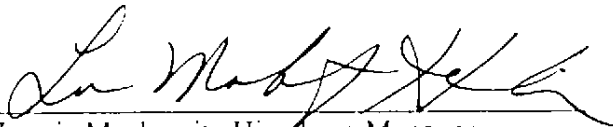
Pursuant to Chapter 605 of the Florida Statutes governing limited liability companies, the Articles of Organization of the undersigned Company are hereby amended as follows:
