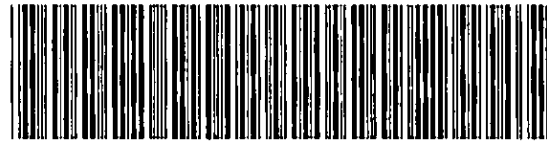

This Amendment to Articles of Organization shall be effective upon filing.


