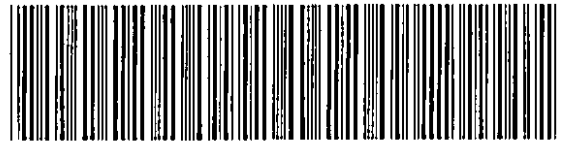

Article IV – Management of Business is hereby deleted in its entirety and substituted therefor is the following:


“ARTICLE IV - MANAGEMENT OF BUSINESS

The Company shall be managed by two (2) managers. The Managers are CHARLES B. LADD, JR. and NELSON FERNANDEZ”


